PLANS AND SPECIFICATIONS are on file in the Office of the Chancery Clerk of Monroe County, the LSBP Engineer's office and the Office of the State Aid Engineer, 412 E. Woodrow Wilson Avenue, Jackson, Mississippi. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

The Cost is fifty dollars (\$50.00) for plans and fifty dollars (\$50.00) for the proposal, non-refundable. Certified check or bid bond for five percent (5%) of the total bid, made payable to Monroe County and the State of Mississippi must accompany each proposal. For bidders submitting bids electronically, the bond submitted must be either a bond issued by the Surety in electronic format or the original hard copy of the bid bond must be submitted to the Monroe County Board of Supervisors, 201 W Commerce Street, Aberdeen, MS prior to the bid opening in order for the bid to be valid.

Bids will be accepted only under the name of the Bidder to whom PLANS AND PROPOSALS have been issued by the County Engineer, and whose name appears on the official list of Planholders maintained by the County Engineer.
